V. Old Business ö Item 989-14.

It was moved and seconded to approve proposed changes to the Undergraduate Grade Appeal Procedures.

It was moved and seconded that the ad hoc faculty committee be a committee of five (three from the department involved and two from another department). *amendment failed*

It was moved and seconded that the sentence "The appeal must be filed within one calendar year of the time the grade that is being appealed was assigned" be changed to "All grievances concerning course grades must be filed within one calendar year of the end of the term in which the grade that is being appealed was assigned." *amendment passed*

It was moved and seconded to add the following sentence to procedure step #5: "If the faculty committee determines that the grade should not be changed, it should communicate this conclusion to the student, faculty member and the department head." *amendment passed. amended motion passed.*

A. It was moved and seconded to approve the Consent Agenda Items 989-20 through 989-25. A request was made to consider item 989-20

separately. motion (items 989-21-25) passed

B. Item 989-20. It was moved and seconded to approve the revisions of the graduate grade appeal procedure. It was moved and seconded to amend the revision by adding the phrase "All grievances concerning course grades must be filed within one calendar year of the end of the term in which the grade that is being appealed was assigned." *the amendment passed. the amended motion passed.*

C. Item 989-26. It was moved and seconded to change the policy on Evaluative Criteria, Procedures and General Standards for Initial Appointment, Successive Appointments, Promotion and Tenure (Section II. Promotion, B. 17-20). It was moved and seconded to change "that administrator" to "chancellor". *amendment passed. motion passed.*
