Executive Summary

ScholarWorks@UARK advances the University of Arkansas's land-grant mission by making the research, scholarship, and creative activity of the Fayetteville campus community available without charge to web visitors everywhere. The repository also partners with non-profit and state-affiliated organizations to make their work more discoverable and accessible. The repository is managed by the Office of Scholarly Communications (OSC) and jointly sponsored by the University Libraries and the Office of Research and Innovation. This report covers developments from 1 January through 30 June 2019 in the following areas:

- holdings and usage statistics
- new collections and serials
- promotion and publicity
- process improvements

Holdings and Usage Statistics

During this six-month period, ScholarWorks@UARK saw a modest increase in usage: 345,897 downloads and hits, compared with 302,924 downloads and hits for 1 July through 31 December 2018. In other words, total usage rose by 14%. (Please refer to Figure A.) Figure B shows life-to-date usage and items contributed to the repository by college. During the first half of 2019, the J. William Fulbright College of Arts and Sciences took first place in life-to-date usage (downloads) and life-to-date deposits. Figure C shows life-to-date downloads and deposits of graduate theses and dissertations by college. Fulbright again leads in terms of downloads and number of theses/dissertations. Figure D shows life-to-date downloads and deposits for undergraduate honors theses by college. Here, the College of Engineering dominates with the number of downloads and number of theses.

The world map (Figure E) illustrates the geographic distribution of the repository's users between 1 January and 30 June 2019. Users came to our website from 210 countries. Not surprisingly, the majority were located in the US and the rest of the Anglophone world. Please see the live map on the ScholarWorks@UARK home page. The pie chart (Figure F), covering the same time period, shows that users represented 14,531 institutions; 21% of these were educational institutions.

New Collections and Serials

The repository's featured collections include a patents directory, undergraduate theses, graduate theses and dissertations, the publications of research centers and institutes, and journals and other serials. (See the list of featured collections on pages 4-5.) These collections continue to grow.

Since 1 January 2019, we added two new journals: *Arkansas Law Notes* and *Journal of Research on the College President*. In the Open Education Resources section, we added three new textbooks created through the OER Course Materials Conversion Program. We also began hosting the Community Design Center's Project Reports and the Center for Human Nutrition's Summer Short Course videos.

Promotion and Publicity

In collaboration with the University Libraries' faculty and staff, we promote ScholarWorks@UARK and encourage all members of the campus community both to use the collections and to deposit their own work. Beyond advertising new issues of the various journals on our website, our staff designed magnets advertising the repository and a flyer for University Human Resources to distribute at New Employee Orientation. In collaboration with the Honors College, we hosted an "open office" to assist students with thesis submission. Jessica Kelly, the newly-hired Scholarly Communications Assistant, created "Thesis Writing: A Quick Resource Guide" and wrote a post on the topic for the University Libraries' blog.

Process Improvements

The success of ScholarWorks@UARK requires continual updates to systems and procedures to ensure cost-effective, efficient, and user-friendly operations. For example, Cedar Middleton produced a video which guides undergraduates, step-by-step, through the thesis submission process. We also conducted a survey of library personnel and individuals who assist students with honors thesis submissions. The responses spurred us to develop a strategic plan for publicizing materials in the repository, to create more user-friendly instructions about making submissions, and to provide tips for searching the repository. We intend to make progress in each of these areas over the coming months.

We continually monitor the profession's best practices, U of A policies, and applicable laws to ensure that our systems and processes align. For example, as part of our ongoing effort to improve the accessibility of all materials in the repository, over the past six months, we added captions to 13 videos.

Paul Forness, Scholarly Communications Assistant, is building an application to track publications (and, eventually, data) resulting from federally funded research at the University of Arkansas in order to monitor and facilitate compliance with federal public access mandates. Since the previous progress report, this application – Sherlock – has been open-sourced (hosted on GitHub). The user interface has been improved, and additional features have been developed; these include the ability to generate compliance audit reports, generate spreadsheets for upload into ScholarWorks@UARK, and import data from Web of Science (in-progress). To date, we've used Sherlock to add hyperlinks in the repository to 83 publications. A plan has been established to publicize Sherlock, which includes the creation of user documentation and outreach through various listservs.



1 July 2018 through 30 June 2019 (FY2019)










