A. Provost Sharon Gaber. *Interim Vice Provost Ro DiBrezzo presented the Provost's report today. VP DiBrezzo reported on the following:*

- *The UA will use the online course evaluation program again this fall. Within the week, a one page guideline will come out and includes a link to a movie that gives one an overview of the system. Once the evaluation process begins (the week after Thanksgiving), there will be a one week period of notifications to encourage students to complete the evaluations. Open ended questions are available in this system.*
- *NSF Grant - The UA is working on an NSF grant that focuses on STEM within ENGR, ARSC and AGRI. The letter of intent is due October 4.*
- *ACT 747 - The UA will have representatives at UCA this fall to learn more about/discuss this Act and its implications for Bachelors degrees and the number of hours required to complete this degree.*
- *Inquiry Journal - A new Editor of the Inquiry Journal, our on campus student research journal, will be announced next week.*
