- IV. A motion was made, seconded, and approve to accept the meeting minutes with corrections.

- VI. Elections & Nominations
 - a. Finance Committee Elections

Currently the Committee consists of Eric Specking as Chair and Lonnie Deavens. Trish opened nominations for two Senators to be on the Committee. Donna Carter and Stephanie Bukoski-Smith both nominated themselves to be on the Committee. A motion was made, seconded, and approve to close nominations. There was one abstain from this vote. The University will have an Associate Vice Provost for Graduation and Retention to help with this issue in the Fall 2014.
