Introduction

The *Journal* is the first student-edited law journal in the nation exclusively devoted to the study of food law and policy. It is also the second journal published by the University of Arkansas School of Law, providing its student contributors with invaluable experience. The *Journal* complements the law school's long-standing and respected Graduate Program in Agricultural Law and the National Agricultural Law Center, as well as Northwest Arkansas's unique and thriving food industry.
