- I. The meeting was called to order by chair, Trish Watkins, at 9:30 AM
- II. A motion was made, seconded, and passed to adopt the agenda
- III. Roll Call Elon Turner
- IV. Campus Updates
 - a. Human Resources Updates Debbie McLoud
 - W-2s will be mailed by January 31; please make sure your address is updated in webBASIS
 - 2. Tobacco Attestation completion was 98% this year
 - 3. Employees are encouraged to make sure they are up to date with vaccinations, particularly against mumps
 - Pat Walker Health Center and the Health Department will have immunization clinics in early January to ensure employees are vaccinated
 - a. Check Newswire for more information
 - 4. Workday implementation is set for July 1, 2020
 - 5. Salary issues are still being addressed
 - 6. Minimum wage will increase January 1, 2020 to \$10/hour
 - i. Pay plan has already been adjusted to reflect increase
 - ii. Hourly employee wage rates will need to be adjusted to reflect the new minimum wage requirement
