ON ESTIMATES OF ERROR IN NUMERICAL INTEGRATION

INTRODUCTION

In order to determine numerical approximations for definite integrals, the principal methods used are the trapezoidal rule and Simpson's rule. In this paper, upper bounds are established for the errors obtained by these two methods. The error resulting from use of the trapezoidal rule is expressed in terms of the second derivative of the integrand, and that incurred in Simpson's rule is expressed in terms of the fourth derivative. ^A difference formula, analogous to Taylor's formula with remainder, is established. This relation is then used to derive expressions for the errors in terms of second and fourth differences respectively.

ERROR IN TERMS OF DERIVATIVES

The procedure is based on the Fundamental Theorem of the integral calculus

DIFFERENCE INTERPOLATION FORMULA WITH REMAINDER

When it is difficult to obtain the derivatives of the integrand, Taylor's Formula with remainder may be replaced by a difference interpolation formula with remainder. An expression for the remainder after one term (Mean Value Theorem for differences) for the difference interpolation formula will be extablished. Likewise, an expression for the remainder after two terms will be determined. THEOREM. If the function $f(x)$ is continuous in the interval $a\leq x\leq a+p\delta$, then with each value of x in that interval there is associated a value η satisfying $|\eta| \leq |p|$ such that

f(a+p\delta) = f(a)+p \Delta f(a)+\frac{p(p-1)}{2!} \Delta^2 f(a)+ \ldots +\frac{p(p-1)\ldots (p-n+1)}{n!} \Delta^n f(a+\eta\delta).
$$

The continuity of $f(x)$ implies the continuity of $\Delta f(x)$. Therefore, the last summation over p terms may be replaced by the expression $p\Delta f(\overline{x})$, with $a\overline{\ll}\langle a+p\delta$. This relationship can also be expressed as

f(a+pS) = f(a) + p [f(\bar{x} +S) - f(\bar{x})]

which is designated as the Mean Value Theorem for differences.

COROLLARY. If $f(a+p\delta) = f(a) = 0$, then $f(\overline{x}+\delta) = f(\overline{x})$, where \overline{x} is some intermediary x.
